The BCRTA (Butler County Regional Transit Authority) has successfully secured a two-million dollar grant through the Federal Competitive Bus & Bus Facilities Grant Program, the last bit of funding required to build a multi-modal transportation facility in Oxford, Ohio. "The Butler County RTA provides necessary travel to Oxford residents, and through cooperation with the City of Oxford and Miami University, this additional investment will help improve the local bus system for riders," said Sherrod Brown, US Senator for Ohio. In addition to this federal grant, the BCRTA also received 4.5 million dollars from the Ohio, Indiana, and Kentucky Council of Governments (OKI) through the federal Congestion Mitigation and Air Quality program.
