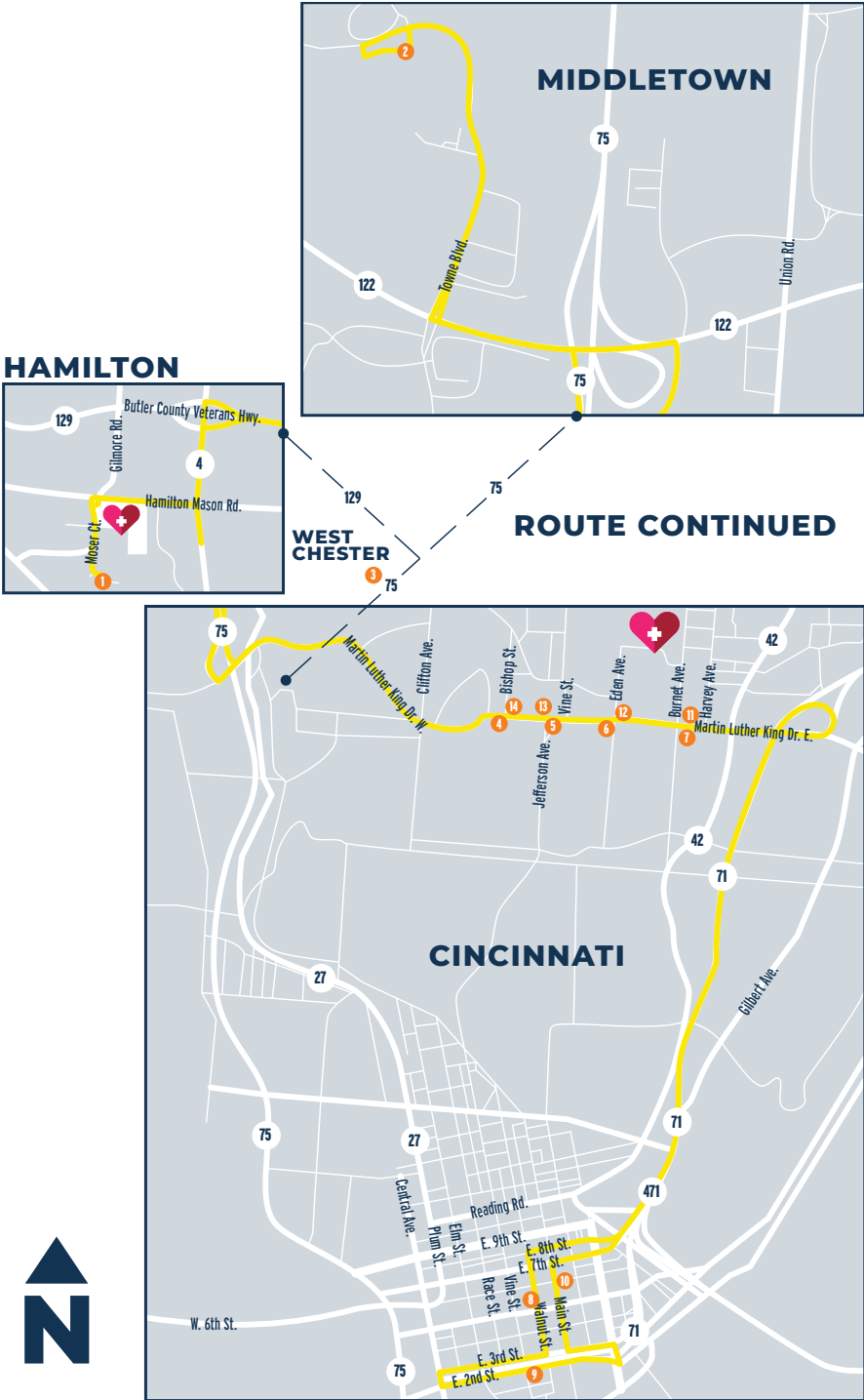
- **Single** – \$5.00 each way
